The Attendee desires to attend the [#PreserveCbus Most Endangered Sites Advocacy Bus Tour] sponsored by CLF and hosted by the Site Owner (the “Program”).

The Attendee hereby freely, voluntarily, and without duress executes this Release under the following terms:

Release and Waiver: The Attendee does hereby release and forever discharge and hold harmless CLF and the Site Owner, and their successors and assigns, from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the Attendee’s attendance at and participation in the Program.

The Attendee understands that this Release discharges CLF and the Site Owner from any liability or claim that the Attendee may have against CLF or the Site Owner with respect to any bodily injury, personal injury, illness, death, or property damage that may result from the Attendee’s attendance at and participation in the Event, whether caused by the negligence of CLF or the Site Owner, or their officers, directors, employees, or agents or otherwise. The Attendee also understands that CLF and the Site Owner do not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

Medical Treatment: The Attendee does hereby release and forever discharge CLF and the Site Owner from any claim which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Attendee’s attendance at and participation in the Event.

Assumption of the Risk: The Attendee understands that the Event includes potential exposure to toxic chemicals, lead based paint, mold, sharp hand tools, power tools, heating devices, electricity, and other adverse site conditions.

The Attendee hereby expressly and specifically assumes the risk of injury or harm in connection with his or her attendance at and participation in the Event and releases CLF and the Site Owner from all liability for injury, illness, death, or property damage resulting from the Attendee’s attendance at and participation in the Event.

Insurance: The Attendee understands that neither CLF nor the Site Owner carries or maintains health, medical, or disability insurance for any Attendee. Each Attendee is encouraged to obtain his or her own medical or health insurance coverage.

Photographic Release. The Attendee does hereby grant and convey unto CLF all right, title, and interest in any and all photographic images and video or audio recordings made by CLF, or their assignees during the Program, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

Other: The Attendee expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of Ohio and that this Release shall be governed by and interpreted in accordance with the laws of Ohio. The Attendee agrees in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
